This includes the Midtown Farmers Market (MFM) which has become a cornerstone program for the organization, and a beloved farmers market by vendors and patrons alike. The MFM has been able to adapt to a variety of challenges in the past several years that allowed it attract an estimated 40,000 market goers in 2024.
